Subject :- Show Cause Notice for sealing of all non-compliant DG sets and Show Cause Notice for Environmental Compensation (EC) - reg

Whereas, for regulated use of DG sets the CAQM has issued Direction No. 73 dated 02.06.2023, revised Direction No. 76 dated 29.09.2023 and an amendment dated 11.12.2024 and for adopting the prescribed schedule for all sectors in NCR including Industrial, Commercial, Residential and Office establishments etc.

And whereas, inspection of **M/s Krishna Farm House, KH No. 12/27. MIN.0-16 12-27 MIN 11-16. 13-26. 0-6. 28 1-15 12-28. 6-10. 26. 5-6. Kapashera, Delhi – 110037** (hereinafter referred as "Addressee") was carried out by officials of DPCC on 03.03.2025 and found engaged in the running of Banquet Hall/Party Lawn. 3 No.s of Diesel Generator sets of 125 KVA each observed in the premises and all are non-compliant wrt CAQM directions.

And whereas, in accordance to the Standard Schedule for EC dated 01.01.2025 issued by the Commission, for each day of violation, *** Rate of EC Charges per day of operation of the non-compliant DG Set shall be levied from 01.10.2023 onwards are as follows:**

- Rs. 7,500 for DG Sets between 20 kW - 125 kW capacity
- Rs. 15,000 for DG Sets > 125 kW but < 800 kW capacity
- Rs. 25,000 for DG Sets of 800 kW or higher capacity

And whereas, CAQM vide its letter dated 31.01.2025 has given concurrence that EC shall be levied considering the total number of days for which non-complying DG set(s) were operated after 01.10.2023 to date of closure directions issued by DPCC/removal of non-compliant DG set/compliance of CAQM direction No.76 as amended. Further maintenance of log book for operation of DG set is mandatory.

And whereas, by way of this Show Cause Notice, you are hereby directed to submit **verified/signed copy of log book (copy must be attached)** as given in the **Table-A** below alongwith an affidavit about the correctness of the statement:

In the absence of logbook/established record of non-compliant DG set(s) operations, the operation of DG set is considered from 01.10.2023 till date of sealing of the non-compliant DG Set /removal of the non-compliant DG /date of compliance of DG Set with CAQM Direction and by way of this you are hereby directed to submit the details as per the calculation/formulae given in the **Table-B** below:

S. no.	No. of DG Set (X)	DG Set capacity	No. of days of operation of DG set (N)	*Rate of EC/day (R)	Total EC in Rs. (XxNxR)

Where, N = No. of days from 01.10.2023 to date of sealing of the non-compliant DG Set /removal of the non-compliant DG /date of compliance of DG Set with CAQM Direction

R = Rate of EC Charges per day of operation of the non-compliant DG Set as indicated above.

This is issued with the approval of the Competent Authority in DPCC

Hence, by way of this notice, the addressee unit is hereby given an opportunity to submit reply as to why the Environmental Compensation as per CAQM policy dated 01.01.2025 should not be confirmed. The reply should reach to this office within 15 days from date of service of this notice, failing which it shall be assumed that you have nothing to say in this regard and the DPCC shall be free to take action as proposed above. This shall also be treated as an opportunity of being heard.
