Whereas, you, Mr. Daya Shankar Kohli, PLOT NO.875 -A, KHASRA NO.403/29, BLOCK NO.E, EAST PARK ROAD, KAROL BAGH, NEW DELHI-110005 (hereinafter referred as addressee) was operating the C&D site.

And whereas, Directions for closure u/s 31 (A) of Air (Prevention and Control of Pollution) Act, 1981 were issued vide F. No. DPCC/CMC-VII/E- 220359/C&D/2024/5898-5903 dated 30.05.2025.

And whereas, you, the addressee unit have submitted representation along with requisite surety bond and undertaking wherein it is stated that you have complied all the deficiencies observed during inspection.
