Subject: Show Cause Notice for Imposition of Environmental Compensation (EC).

Whereas, a complaint forwarded by the office of Assistant Registrar Supreme Court of India vide letter dated 12.09.2022 was received in this office against a unit operating illegally at H.No. 266, Gali No 2, Ghondli, Delhi-110051.

And whereas, inspection of your unit was carried out by DPCC officials 11.01.2023 and during inspection, it was observed that, the addressee unit was operating in the residential/non-conforming area and engaged in activity of “**manufacturing of railings, doors & windows panels using steel bars (Light Engineering/ Fabrication work)**” without obtaining license/consent from any government/regulating body.

And whereas, Hon'ble National Green Tribunal vide orders dated 05.08.2019 & 19.11.2019 in OA No. 601/2018 in the matter of “Mayank Manohar & Paras Singh, Reporter, the Times of India Vs. Govt. of Delhi & Ors.” has also directed closure of impermissible industrial units in residential/ non-conforming areas of NCT of Delhi and levying Environmental Compensation (EC) for the damage caused by illegal operation keeping in view the ‘Polluters Pay Principle’.

And whereas, activity carried out by the addressee unit falls under **White Category** as per DPCC categorisation, and as per the extant policy of DPCC dated 30.03.2022, Sector-7 for non-confirming areas you shall be liable to pay lumpsum **Environmental Compensation (EC) of Rs. 40,000/- (Rupees Forty Thousand Only)** to DPCC in the form of DD in favour of DPCC.

Now, therefore, you are hereby directed to show cause as to why the Environmental Compensation (EC) of Rs. 40,000/- (Rupees Forty Thousand Only) should not be levied upon you (the addressee).

Your reply, (if any) should reach this office within 15 days from the date of issue of this notice. In case of failure, it will be presumed that the addressee has nothing to say in this regard and the aforementioned proposed EC of Rs. 40,000/- (Rupees Forty Thousand Only) shall be confirmed without any further reference in this regard.
