Subject: Environmental Compensation (EC)-reg.

And whereas, a meeting of the Solid Waste Management Monitoring Committee (SWMC) meeting held on 25.04.2023 at Raj Niwas under Chairmanship of Hon'ble Lieutenant Governor, Delhi. In the backdrop of letter F. No. DPCC/CMC-I/illegal jeans dyeing unit/2023/ MS/18 addressed to the Deputy Commissioner, MCD, Shahdara North Zone, with the copies to concerned authorities and subsequent letter F. No. PS/ MS/DPCC/2023/21, joint drive against Illegal Jeans dyeing units was undertaken. A joint team comprising of officials of DPCC, MCD, Revenue Department, Delhi Police and BSES visited the areas of Tukhmipur, Biharpur, Karawal Nagar, Sonia Vihar and Gokulpuri.

And whereas, during joint inspection on 11.05.2023 at M/s Sanjeev Sharma, 1st Floor, B-62 Gali No. 10, Neher Road, Gokulpuri Village, Delhi -110093 (hereinafter called the addressee unit) were operating in residential/non-conforming area and found engaged in activity of **Jeans dyeing** without any license from regulatory authority and pollution control device and discharging untreated waste water directly into drain leading to River Yamuna.

DPCC vide its letter (F.No. DPCC/CMC-I/illegal jeans dyeing unit/2024/512-513 dated 02.06.2025) has imposed an Environmental Compensation (EC) of Rs. 10,00,000/- (Rs. Ten Lakh only) on you the addressee. However, you the addressee has failed to submit the above said Environmental Compensation (EC) till date.

And whereas, the addressee unit is hereby being provided with an opportunity to submit the EC of amount **Rs. 10,00,000/- (Rs. Ten Lakh only)** for the deficiencies observed during inspection by the officials of DPCC at the addressee unit.

Now therefore, you are hereby once again directed to deposit Environmental Damage Compensation (EDC) of **Rs. 10,00,000/- (Rs. Ten Lakh only)** in the form of DD, in favour of **Delhi Pollution Control Committee** within 15 days from issuance of this letter, failing which necessary action shall be taken including recovery of said EC as arrear of land revenue through Revenue Department, GNCTD.
