**Subject: Regarding revocation of Consent order G-21742 issued to M/s KT Enterprises.**

**Whereas,** Central Pollution Control Board has delegated all its powers and functions under the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of pollution) Act, 1981 in respect of Union Territory of Delhi to Delhi Pollution Control Committee vide notification No. I S.O. 198 (E) dated 15.03.1991.

**Whereas,** it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall Establish an industrial unit in an Air Pollution Control Area of Union Territory of Delhi.

**Whereas,** it is mandatory provisions under section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 that no person without the previous consent of the DPCC shall Establish or take any steps to establish any industry, operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land.

**Whereas,** as per the provisions under section 27(2) of Water (Prevention & Control of Pollution) Act, 1974 and the provisions under section 21(4) of Air (Prevention & Control of pollution) Act, 1981 SPCB/PCC may cancel any such consent before the expiry of the period for which it is granted or refuse further consent after such expiry if the conditions subject to which such consent has been granted are not fulfilled.

**And Whereas,** during an inspection of your unit M/s KT Enterprises, Owner: Taiyyab, 8/1, Jawahar Nagar, Johripur, Near Gurudwara, Delhi-110094 on 07.05.2025, you (the addressee) were found operating your unit with valid consent to operate for activity Mfg. of reprocessed pre granules and other injection moulded items (without washing) from Delhi Pollution Control Committee but engaged in activity of Mfg. of reprocessed PVC granules (with washing) and it was observed that you are not complying with the provision under Air & Water Acts.

Therefore, by way of this notice you, M/s KT Enterprises, Owner: Taiyyab, 8/1, Jawahar Nagar, Johripur, Near Gurudwara, Delhi-110094 having consent order G-21742 dated 27/01/2022 with validity up to 02.12.2026 issued for activity Mfg. of reprocessed pre granules and other injection moulded items (without washing) under Orange Category, are hereby given an opportunity to show cause why your consent shall not be revoked.

Your reply in this regard, if any, shall reach the office of DPCC within 15 days of the issuance of this notice failing which your said consent shall be revoked without any further reference followed by necessary action as per Law.
