Subject: Show Cause Notice u/s 21/22 of Air (Prevention & Control of Pollution) Act, 1981 as amended to date and u/s 25/26 of Water (Prevention & Control of Pollution) Act, 1974 amended to date.

And whereas, Central Pollution Control Board has delegated all its powers and functions under Air (Prevention & Control of Pollution) Act, 1981 and under Water (Prevention & Control of Pollution) Act, 1974 in respect of Union Territory of Delhi to Delhi Pollution Control Committee.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (I) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. GSR 106 (E) dated 20.02.1987.

And whereas, it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall establish or operate any industrial plant in air pollution control area.

And whereas, it is mandatory provisions u/s 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 that no person without the previous consent of DPCC shall Establish or take any steps to establish any industry, operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent in to a stream or on land.

And whereas, an inspection of your unit M/s Preeti Goel, Owner: Manish Jain, Plot No. 13 & 13A, Kh. No. 8/22, G/F, Jawahar Nagar Ind. Area, Delhi-110094 was conducted by the representatives of DPCC on 08.05.2025 and it was found that you are operating your unit without valid consent to operate under **GREEN CATEGORY** from Delhi Pollution Control Committee with the activity of **Grinding of PVC/ Waste Plastic (without washing)**.

And whereas, case of the addressee unit was taken up by the Competent Authority in Delhi Pollution Control Committee and decided to issue Show Cause Notice u/s 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 and u/s 25/26 of Water (Prevention & Control of Pollution) Act, 1974 as amended to date.

Now, therefore, by way of this Notice, you are hereby directed to comply with the provisions of the Air (Prevention & Control of Pollution) Act, 1981 and Water (Prevention & Control of Pollution) Act, 1974 amended to date and obtain the Consent to Operate (CTO) from DPCC at the earliest.

Your reply, along with application of consent under Air Act, 1981 & Water Act, 1974 should be submitted to this office within 15 days from the service of this notice, failing which it shall be presumed that you have nothing to say in this regard and action for closure including prosecution proceedings shall be initiated under the provisions of the above said Acts without any further reference to you.

This is being issued as per the decision taken by the Competent Authority, DPCC.
