Sub: Direction for Imposition of Environmental Damage Compensation (EDC) of amount Rs. 40,000.

Whereas Hon'ble National Green Tribunal vide orders dated 05.08.2019 & 19.11.2019 in OA No. 601/2018 in the matter of "Mayank Manohar & Paras Singh, Reporter, the Times of India Vs. Govt. of Delhi & Ors." has also directed closure of impermissible industrial units in residential/ non-confirming areas of NCT of Delhi and levying Environmental Compensation (EC) for the damage caused by illegal operation keeping in view the 'Polluters Pay Principle'.

And whereas in compliance of Hon'ble NGT order dated 22.07.2024 in the matter of "Ramesh Chand v/s Municipal Corporation of Delhi & Ors." in OA No. 146/2024, a joint inspection of you unit **Mr. Nabeeb S/o Munri, Block E, E-292, New Ashok Nagar, Delhi 110096**, (Herein after referred as addressee) was carried out by team comprising of officials of DPCC, MCD and Delhi police on 09.12.2024.

And whereas during inspection, it was observed that, you were operating in the residential/non-confirming area without obtaining license/consent from any government/ regulating body and engaged in activity of "Scrap Shops and godown" which comes under the category of warehousing.

And whereas, based on the observation during inspection you were issued SCN for imposition of EDC dated 07.04.2025 of amount Rs. 40,000/- (Rupees Forty Thousand only).

And whereas, you have not submitted reply/reply submitted and found unsatisfactory.

Now therefore, in exercise of powers conferred upon it, under the provisions of said acts as amended to date, the proposed Environmental Damage

Compensation (EDC) of amount Rs. 40,000/- (Rupees Forty Thousand only). is hereby confirmed/imposed on you. Therefore you are directed to deposit EC of amount Rs. 40,000/- (Rupees Forty Thousand only) in the form of Demand Draft in favour of DPCC within 15 days from the issuance of this direction.
