Subject: Direction for Confirmation/Imposition of Environmental Compensation.

Whereas, Hon'ble National Green Tribunal vide its orders dated 15.01.2019, 30.05.2019, 30.10.2019 and 19.11.2019 in OA No. 25/2019 titled as, "Abdul Farukh Vs Govt. of NCT of Delhi" regarding remedial action against illegal extraction of ground water by installing unauthorized tube-wells has issued number of directions to Delhi Pollution Control Committee (DPCC), Delhi Jal Board and Revenue Department for compliance.

And whereas, Chairman, DPCC in the various meetings regarding review of progress of action on borewell operating in non-conforming/residential areas, Delhi, directed that action of sealing of such borewell and imposition of EC.

And whereas, SDM (Yamuna Vihar) vide its letter (NO:- SDM/Y.V/Borewell/2024/1198-1201) dated 11.03.2025 informed that based on the letter received from Delhi Jal Board (DJB) (NO:- DJB/SE(C)-02/2024/1472) dated 12.12.2024, borewell of **Sh. Rajender Kumar, C-427, Gali No. 10, Brijpuri, Delhi-110094** which was found engaged in illegal extraction of groundwater without permission, has been sealed.

And whereas, in view of Hon'ble NGT directions/orders and in view of the non-compliance of the statutory requirements, DPCC keeping in view the 'Polluter Pays' Principle has decided to levy Environmental Compensation (EC) on the addressee for causing damage to the environment by illegal extraction of groundwater.

And whereas, DPCC had issued a Show Cause Notice for imposition of Environmental Compensation (EC) **Rs 30,000/- (Rupees thirty thousand Only)** to you regarding illegal extraction of groundwater without permission vide letter no. DPCC-J023/5/2025-CMC1/303-305 dated 01.05.2025 (copy enclosed).

And whereas, you have not submitted any reply/response to the said Show Cause Notice & not deposited Environmental Compensation (EC) of **Rs 30,000/- (Rupees thirty thousand Only)** till date.

And whereas, the Competent Authority in DPCC has decided to confirm the EC of **Rs 30,000/- (Rupees thirty thousand Only)** as an interim EC on **Sh. Rajender Kumar**

Now therefore, you are hereby directed to deposit interim Environmental Compensation (EC) of **Rs 30,000/- (Rupees thirty thousand Only)** in the form of DD, in favour of DPCC within 15 days from the issuance of this directions/order failing which necessary action shall be taken as per Law.

This is being issued as per the decision of Competent Authority, DPCC.
