Subject: Direction for Confirmation/Imposition of Environmental Compensation (EC).

Whereas, in the order dated 07.05.2004, Hon'ble Supreme Court directed that all Industrial units operating in non-conforming residential areas of Delhi in violation of Master Plan of Delhi have to be closed down/ shifted.

And whereas, Chairman, DPCC in the various meetings regarding review of progress of action on illegal dyeing industries operating in non-conforming/residential areas, Delhi, directed that action of closure of jeans dyeing units should be continued.

And whereas, a joint team comprising of officials from MCD, DPCC, BSES, Revenue, DJB and Delhi police was constituted for effective closure action against illegal water polluting units specially jeans dyeing/ washing industries and electroplating units operating in Village Kirari and surrounding non-conforming areas and accordingly, joint inspection was carried out on 06.07.2024 to ascertain the facts.

And whereas, during the joint inspection, you (hereinafter referred as the addressee) were found engaged in the activity of **Jeans dyeing and washing** at the alleged site without any pollution control device and discharging untreated wastewater directly into the drain leading to River Yamuna & operating without obtaining license/consent from any government/regulating body and was sealed by MCD officials in the presence of joint team.

And whereas, you (the addressee), were operating in non- conforming/residential area and generating wastewater which is highly toxic and carcinogenic in nature and discharging your untreated wastewater into the river Yamuna directly or indirectly through various drains

And whereas, Hon'ble National Green Tribunal vide orders dated 05.08.2019 & 19.11.2019 in OA No. 601/2018 in the matter of "Mayank Manohor & Paras Singh, Reporter, the Times of India Vs. Govt. of Delhi & Ors has also directed closure of impermissible industrial units in residential/ non-confirming areas of NCT of Delhi and levying Environmental Compensation (EC) for the damage caused by illegal operation keeping in view the 'Polluters Pay Principle.

And whereas, activity carried out by the addressee unit falls under Red category as per DPCC categorisation and has high water pollution potential. As per the extant policy of DPCC dated 30.03.2022, Sector-7 for non-confirming areas, you shall pay lump sum Environmental Compensation (EC) of Rs. 10,00,000/- (Rupees Ten Lakhs Only) to DPCC in the form of DD in favour of DPCC.

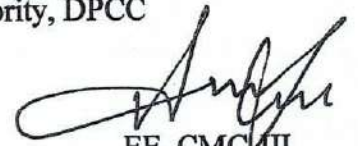
And whereas, DPCC has issued a Show Cause Notice for Environmental Compensation (EC) Rs. 10,00,000/- (Rupees Ten Lakhs Only) to you vide letter no. DPCC-L023/15/2024-CMC3-1928 dated 25.11.2024

And whereas, you have not submitted any reply/response to the said Show Cause Notice & not deposited Environmental Compensation (EC) of Rs.10,00,000/-(Rupees Ten Lakhs Only) till date.

Now therefore, the Competent Authority in DPCC has decided to confirm the EC of Rs. **10,00,000/-(Rupees Ten Lakhs) Shri Vinod Kumar Kh. no. 374, Village Kirari Near Shiv Mandir, Delhi-110086.**

Therefore, you are hereby directed to deposit Environmental Compensation (EC) of Rs. 10,00,000/- (Rupees Ten lakh only) in the form of DD, in favour of DPCC within 15 days from the issuance of this directions/order failing which necessary action shall be taken as per Law.
