Subject: Reminder letter for submission of Environmental Compensation (EC).

Ref: DPCC letter F.No. DPCC/CMC-I/NGT/ OA56/2023/556-558 dated 13.06.2025 – Copy enclosed.

This is in compliance of Hon'ble NGT order dated 09.02.2023 in OA no. 56/2023 in the matter of "Sanjeev Kumar Vs Devendra Singh", a joint inspection of your unit was carried out by officials of DPCC, MCD, Revenue Department, Delhi Police and BSES on 27.02.2023. During inspection, you (hereinafter called the addressee) were operating in the residential/non-conforming area and engaged in activity of "Zinc Plating" without any pollution control device and operating in non-conforming area, discharging untreated wastewater directly into drain leading to River Yamuna.

And whereas, DPCC vide its letter F.No. DPCC/CMC-I/NGT/OA56/2023/6076-78 dated 13.02.2025, has imposed an **Environmental Compensation (EC) of Rs. 10,00,000/- (Rs. Ten Lakh only)** on you the addressee. Further, vide letter F.No. DPCC/CMC-I/NGT /OA56 /2023/ 556-558 dated 13.06.2025, first reminder letter for submission of Environmental Compensation was also issued to you the addressee. However, you the addressee has failed to submit the above said Environmental Compensation (EC) till date.

Now therefore, you are hereby once again directed to deposit Environmental Damage Compensation (EDC) of Rs. 10,00,000/- (Rs. Ten Lakh only) in the form of DD, in favour of **Delhi Pollution Control Committee** within 15 days from issuance of this letter, failing which necessary action shall be taken including recovery of said EC as arrear of land revenue through Revenue Department, GNCTD without any further reference.
