REMINDER**Subject: Directions for Confirmation of Environmental Damages Compensation.****Ref: F. No. DPCC/(3)(9)(346)/Vig.23/4457-59 dated 27.06.2025**

Whereas, Central Pollution Control Board has delegated all its powers and functions under the Water (Prevention & Control of Pollution) Act, 1974 and under the Air (Prevention & Control of Pollution) Act, 1981 in respect of Union Territory of Delhi to Delhi Pollution Control Committee.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (I) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. G.S.R 106 (E) dated 20.02.1987.

And whereas, it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall establish or operate any industrial plant in air pollution control area.

And whereas, it is a mandatory provision under u/s 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, that no person without the previous consent of the DPCC shall establish or take any steps to establish any industry, operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land or operate any industrial plant in air pollution control area.

And whereas, you M/s Masters, Ground Floor, Shop No.7-8, Deep Cinema Complex Central Market, Ashok Vihar, Ph-I, Delhi-110052 (herein after referred as addressee) found operating and engaged in the activity of Resturant/Fast Food Centre.

And whereas, Directions for Confirmation of EDC was issued to you on 27.06.2025 for imposing Environmental Damage Compensation of Rs.7,50,000/- (Rs. Seven Lakh Fifty Thousand Only).

And whereas, you have not deposited Environmental Compensation (EC) of Rs.7,50,000/- (Rs. Seven Lakh Fifty Thousand Only) till date.

Hence, you are once again hereby directed to deposit the Environmental Compensation of Rs. 7,50,000/- (Rs. Seven Lakh Fifty Thousand Only) by way of D.D in favour of Delhi Pollution Control Committee within 15 days of issuance of these directions, failing which penal action shall be initiated against you as per law.

This is being issued as per the approval of Competent Authority, DPCC.
