Subject: Reminder Show Cause Notice (SCN) in relation to Show Cause Notice for Environmental Compensation Damages and compliance report of Direction for closure u/s 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 as amended to date dated 27.04.2022.

And whereas, you M/s Minto Yadav S/o Prem Chand, 992, Pan Mandi, Sadar Bazar, Delhi-110006 (hereinafter referred as the addressee) is engaged in the activity of Cattle Dairy.

And whereas, an inspection of your dairy was conducted by the officials of Veterinary Department & Police P.S. Sadar Bazar on 04.03.2022 and you (the addressee unit) are operating your dairy farm without having a valid Consent to Establish / Operate from DPCC, operating in violation of the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981, as amended to date.

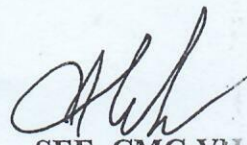
And whereas, Directions for closure u/s 33 (A) of the Water (Prevention & Control of Pollution) Act, 1974 and Show Cause Notice for imposition of Environmental Compensation Damages of Rs. 1,00,000/- (Rupees One Lakh Only) were issued to you vide letter dated 27.04.2022 (copies enclosed). However, you have neither submitted compliance report nor deposited EDC till date.

And whereas, your case was taken up by the Competent Authority in Delhi Pollution Control Committee and decided to issue reminder Show Cause Notice for Environmental Compensation Damages and compliance report of Direction for closure u/s 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 dated 27.04.2022, as amended to date.

Now therefore, it is decided that you shall deposit the Environmental Compensation of Rs. 1,00,000/- (Rs. One Lakh Only) in the form of DD in favour of "Delhi Pollution Control Committee" and compliance report of the said closure directions dated 27.04.2022 within 15 days of issuance of these directions.

This is being issued as per the approval of Competent Authority, DPCC.

Subject: Show Cause Notice for Environmental Damages Compensation-reg.

And whereas, you M/s Minto Yadav S/o Prem Chand, 992, Pan Mandi, Sadar Bazar, Delhi-110006 (hereinafter referred as the addressee) is engaged in the activity of Cattle Dairy.

And whereas, an inspection of your residence/dairy was conducted by the officials of Veterinary Department & Police P.S. Sadar Bazar on 04.03.2022 and the observations/deficiencies found during inspection are as follows:

1. The cattle dairy found operating without valid consents from DPCC.

And whereas, it is evident that you were causing water pollution and also damaging to the Environment and it is liable to impose Environmental Compensation of Rs. 1,00,000/- (Rs. One Lakh Only).

And whereas, as per your inspection you (the addressee unit) found operating the dairy without having a valid Consent to Operate from DPCC in violations of the provisions of the Water (Prevention and Control of Pollution) Act, 1974.

Now, therefore, the Competent Authority in Delhi Pollution Control Committee has decided why not the **Environmental Damages Compensation of Rs. 1,00,000/- (Rs. One Lakh Only)** should be levied upon you (the addressee unit).

Your reply, (if any) along with supporting documents, should reach this office **within 15 days from the date of issue of this notice**. In case of failure, it will be presumed that you have nothing to say in this regard and the aforementioned proposed EDC shall be levied upon you/confirmed without any further reference in this regard.
