REMINDER

Subject: Direction for Confirmation of Environmental Compensation.

Whereas, in its order dated 07.05.2004 in WP(C) No. 4677 of 1985 titled as "M.C. Mehta Vs. Union of India & Others", the Hon'ble Supreme Court directed that all industrial units operating in non-conforming/ residential areas of Delhi in violation of the Master Plan of Delhi have to be closed down/ shifted by the concerned land owning agencies.

And whereas, Hon'ble National Green Tribunal vide orders dated 05.08.2019 & 19.11.2019 in OA No. 601/2018 in the matter of "Mayank Manohar & Paras Singh, Reporter, the Times of India Vs. Govt. of Delhi & Ors." has also directed the closure of impermissible industrial units in residential/ non-confirming areas of NCT of Delhi and levying Environmental Compensation (EC) for the damage caused by illegal operation keeping in view the 'Polluters Pay Principle'.

And whereas, in view of the complaint received on Twitter (X), MCD had decided to form a joint team consisting of officials of MCD, DPCC and BSES. The joint team conducted the inspection in the Rithala area on 09.10.2024.

And whereas, during the inspection on 09.10.2024, you, **M/s Owner/Occupier Khasra no. 942, first floor, Rithala Village Road, GN group Rice Mill, Rithala, Delhi-110085**, was found engaged in the activity of **Jeans Dyeing & Washing**, operating in a non-conforming area without installing ETP and were discharging untreated wastewater into a drain leading to river Yamuna. The said unit was effectively sealed by MCD and electricity connection was disconnected on the spot during the inspection by joint team.

And whereas, the activity carried out by you, falls under the Red category as per DPCC categorization, and activity has high water pollution potential & as per the extant EC policy of DPCC dated 30.03.2022, for non-confirming areas, you shall be liable to pay Environmental Compensation (EC) amount of **Rs.10,00,000/- (Rupees Ten Lakhs Only)**.

And whereas, Show Cause Notice for Environmental Compensation (EC) as per Standard Schedule for Environmental Compensation (EC) Charges by the DPCC directions dated 30.03.2022 issued to you vide letter dated 25.11.2024.

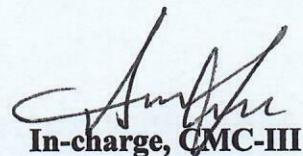
And whereas, Show Cause Notice dated 25.11.2024 was returned undelivered to DPCC and the same was delivered by hand at your said unit at **M/s Owner/Occupier Khasra no. 942, first floor, Rithala Village Road, GN group Rice Mill, Rithala Delhi-110085** on 27.01.2025 by DPCC officials.

And whereas, in response to the above said SCN, no reply has been received from your end within the given stipulated time period.

And whereas, your case was put Competent Authority in DPCC, Environmental Compensation of Rs.10,00,000/- (Rupees put up before the Competent Authority, as decided by the Ten Lakh Lakhs Only) is hereby imposed/confirmed upon you, M/s Owner/Occupier Khasra no. 942, first floor, Rithala Village Road, GN group Rice Mill, Rithala, Delhi-110085, as per the DPCC office order dated 30.03.2022, for the violations as mentioned above.

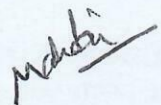
You have not submitted EDC till date. Hence, you are once again directed to deposit Environmental Compensation (EC) of **Rs. 10,00,000/- (Rupees Ten Lakhs Only)** to this office in the form of DD in favour of "Delhi Pollution Control Committee" within 15 days from the date of issuance of these directions failing which necessary action shall be taken as per law.

This is being issued with the approval of the Competent Authority in DPCC.
