REMINDER**Subject: SCN for Environmental Damage Compensation.****Ref: F.No.DPCC/CMC-VII/2022/16192-93 dated 23.02.2022**

Whereas, Central Pollution Control Board has delegated all its powers and functions under the Water (Prevention & Control of Pollution) Act, 1974 and under the Air (Prevention & Control of Pollution) Act, 1981 in respect of Union Territory of Delhi to Delhi Pollution Control Committee.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (I) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. GSR 106 (E) dated 20.02.1987.

And whereas, it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall establish or operate any industrial plant in air pollution control area.

And whereas, it is a mandatory provision under u/s 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, that no person without the previous consent of the DPCC shall establish or take any steps to establish any industry, operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land or operate any industrial plant in air pollution control area.

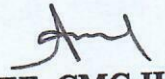
And whereas, you, **M/s Shiv Shanker & Sons, Building Material and Suppliers Opposite RP-Market, Pitampura, Delhi-110034** (herein after referred as the addressee unit) found engaged in the activity of Building material supplier.

And whereas, an inspection of your unit was conducted by the officials of DPCC on 27.12.2021 and the observations/deficiencies found during inspection are as follows:

1. Heap of building material observed at Prembari Pul near Wazirpur Industrial Area near Haiderpur canal on Government land.
2. Building Material found partially covered.

And whereas, it is evident that you the addressee is causing pollution and also damage to the Environment which is liable for action as per "Polluter Pays" Principle. SCN was issued to you the addressee on dated 23.02.2022 for Rs.10,000/- (Rs. Ten thousands Only) and you have not submitted EDC till date.

Hence by way of this notice, you are hereby given an opportunity to submit your reply as to why the aforesaid EDC as proposed for past violation as mentioned above should not be confirmed. Your reply should reach to this office within 15 days from date of service of this notice, failing which it shall be assumed that you have nothing to say in this regard and the competent authority of DPCC shall be free to take action as proposed above. This may also be treated as an opportunity of being heard.
