Subject :- Directions for imposition of Environmental Compensation (EC) - reg

Whereas, Central Pollution Control Board has delegated all its powers and functions under the Air (Prevention and Control of Pollution) Act, 1981 and Water (Prevention and Control of Pollution) Act, 1974, as amended to date, in respect of Union Territory of Delhi to Delhi Pollution Control Committee (DPCC) vide Notification dated 15.03.1991.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (1) of section 19 of the Air (Prevention and Control of Pollution) Act, 1981, as amended to date, vide Notification of Ministry of Environment & Forest, Govt. of India, No. GSR 106 (E) Dated 20.02.1987.

And whereas, as per the mandatory provisions u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981, no person without the previous consent of the State Pollution Control Board (DPCC in case of Delhi) shall establish or operate any industrial plant in an Air Pollution Control Area.

And whereas, as per the mandatory provisions u/s 25/26 of the Water (Prevention and Control of Pollution) Act, 1974, no person without the previous consent of DPCC shall Establish or take any steps to establish any industry, operation or process or any treatment and disposal system or any extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land, bring into use any new or altered outlet for the discharge of sewage or begin to make any new discharge of sewage.

And whereas, inspection of M/s Spara Corporation Private Limited, G-1, Pushpanjali Farms, Dwarka Link Road, Bijwasan, and Delhi-110037 (hereinafter referred as "Addressee" was carried out by officials of DPCC on 28.02.2025 and found engaged in the Activity of running of Banquet Hall/Party Lawn.

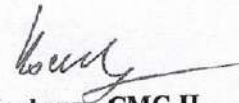
And whereas, Show Cause Notice for Environmental Compensation of Rs. 3,75,000/- (Rupees Three Lakhs seventy Five Thousand only) was issued to you vide letter dated 28.03.2025 in view of deficiencies observed during the inspection.

And whereas, in response to the above Show Cause Notice, you have submitted your reply vide letter dated 09.04.2025 which was considered by competent Authority and found not satisfactory.

Now, therefore, the Competent Authority in DPCC, as per the DPCC office order dated 30.03.2022, Environmental Compensation (EC) of Rs. 3,75,000/- (Rupees Three Lakhs seventy Five Thousand only) hereby impose/confirm upon the Addressee unit for the deficiencies observed by DPCC.

Hence, the Addressee unit is hereby directed to deposit Environmental Compensation (EC) of Rs. 3,75,000/- (Rupees Three Lakhs seventy Five Thousand only) to this office in the form of DD in favour of "Delhi Pollution Control Committee" within 15 days from the date of issuance. Failure to deposit the said EC in DPCC will attract action by the concerned SDM for recovery of EC as an arrears of land revenue.
