REMINDER

Subject: Show Cause Notice u/s 25/26 of Water (Prevention and Control of Pollution) Act, 1974 and u/s 21/22 of Air (Prevention and Control of Pollution) Act, 1981, as amended to date.

Whereas, Central Pollution Control Board has delegated all its powers and functions under the Water (Prevention & Control of Pollution) Act, 1974 and under the Air (Prevention & Control of Pollution) Act, 1981 in respect of Union Territory of Delhi to Delhi Pollution Control Committee.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (1) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. GSR 106 (E) dated 20.02.1987,

And whereas, it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall establish or operate any industrial plant in air pollution control area.

And whereas, it is a mandatory provision under is 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, that no person without the previous consent of the DPCC shall establish or take any steps to establish any industry, operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land or operate any industrial plant in air pollution control area.

And whereas, you, M/s Owner/ Occupier, Khasra no.-993 (Ground floor), Rithala, Delhi-110085 (herein after referred as addressee) were engaged in the activity of making wooden blocks/furniture using wood as raw material.

And whereas, an inspection of your unit was conducted by the officials of DPCC on 09.01.2025 and the observations/deficiencies found during inspection are as follows:

1. The unit found operational and engaged in the activity of making wooden blocks/furniture using wood as raw material.
2. The Unit was found operational without having valid permission of DPCC.

And whereas, your case was taken up by the Competent Authority in Delhi Pollution Control Committee and decided to issue Show Cause Notice u/s 25/26 of Water (Prevention and Control of Pollution) Act, 1974 and u/s 21/22 of Air (Prevention and Control of Pollution) Act, 1981, as amended to date.

Now therefore in exercise of powers conferred upon it, under the provisions of said acts as amended to date, hereby issue the following proposed directions:

You are directed to obtain White Category Undertaking failing which necessary action will be taken as per law.

Please note that for activity classified under White Category acknowledgement as per prescribed undertaking will suffice the consent by DPCC

Hence by way of this notice, you are hereby given an opportunity to submit your reply as to why the necessary action should not be taken against you. Your reply should reach to this office within 15 days from date of issue of this notice, failing which it shall be assumed that you have nothing to say in this regard and the competent authority of DPCC shall be free to take action as deemed fit. This may also be treated as an opportunity of being heard.

This issues as per the approval of the Competent Authority, Delhi Pollution Control Committee.
