Subject: Notice u/s 21/22 of the Air (Prevention and Control of Pollution) Act, 1981 and 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 as amended to date.

Whereas, Central Pollution Control Board is the State Board for all the Union Territories to exercise powers and perform functions under the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981, as amended to date.

And whereas, Central Pollution Control Board has delegated all its powers and functions under the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981, in respect of Union Territory of Delhi to Delhi Pollution Control Committee (DPCC) Vide Notification dated 15.03.1991.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control Area, under sub section (I) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981, vide Notification No. GSR 106 (E) Dated 20.02.1987.

And whereas, as per section 21(1) of the Air (Prevention & Control of Pollution) Act, 1981, as amended to date no person shall, without the previous consent of the State Pollution Control Board (DPCC in case of Delhi), establish or operate any industrial plant in an Air Pollution Control Area.

And whereas, as per section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974, as amended to date, it is mandatory to obtain Consent from Delhi Pollution Control Committee in respect of any industry or operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or on land.

And whereas, you, **M/s Owner/Occupier, H-3, Back side Ground Floor, Udyog Nagar, Delhi-110041** (hereinafter referred as addressee) are operating your unit at the above said address. An inspection was carried out by DPCC officials at the addressee unit on **06.06.2025** and the following observations were made:

1. The unit is engaged in the activity of **EVA Footwear and PVC Footwear (Using Fresh Raw Material)**.
2. The unit was found operating without consent under the Air and Water Act.

By way of this notice, you, the addressee, are hereby directed to clarify why the said unit is operating in violations of provisions of the Air and Water Act. Your reply should reach this office within 15 days from the date of service of this notice, failing which it shall be presumed that you have nothing to say in this regard and further necessary actions may be initiated against the addressee unit as per DPCC rules and regulations.

This is being issued as per the approval of Competent Authority, DPCC.
