Subject: Reminder Show Cause Notice (SCN) in relation to SCN for imposition of EC dated 21.11.2022.

Whereas, Central Pollution Control Board is the State Board for all the Union Territories to exercise powers and performs functions under the Air (Prevention & Control of Pollution) Act, 1981.

And whereas, Central Pollution Control Board has delegated all its powers and functions under Air (Prevention and Control of Pollution) Act, 1981 in respect of NCT of Delhi-to-Delhi Pollution Control Committee vide Notification No. S.O. 198 (E) dated 15.03.1991.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (1) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. GSR 106 (E) dated 20.02.1987.

And whereas, Delhi faces grave air pollution particularly in winter season and level of pollutants like Particulate Matter Concentration (PM_{2.5} and PM₁₀) goes much beyond the prescribed standards for Ambient Air Quality.

And whereas, the Commission for Air Quality Management in NCR and adjoining areas has repeatedly taken up the matter relating to air pollution with Government of NCT of Delhi and various organizations and has issued various Directions, Advisories and Orders for effective implementation of measures for abating air pollution in NCR from time to time.

And whereas, you, **Sh. Yash Arora, 1/26, Roop Nagar, Delhi - 110007** (hereinafter referred as addressee) were operating a construction site at the said address and engaged in the running of Construction & Building Project.

And whereas, an inspection of the aforesaid site was conducted by DPCC officials on 15.10.2022 and it was observed that you are violating the dust pollution mitigation norms. During the inspection, the following observations/deficiencies were found:-

- i. Site found operational and the plot area of the unit is approx. 240 sq. m. as informed by the owner.
- ii. Dust/Wind breaking walls of appropriate height around the periphery of the construction site were not provided.
- iii. Tarpaulin or green net on scaffolding around the area under construction and the building were not provided.
- iv. Construction material was stored on the foot path and on the road.
- v. Site found using groundwater illegally.

And whereas, Show Cause Notice (SCN) for imposition of Environmental Damage Compensation (EDC) of Rs. 90,000/- (Rupees Ninety Thousand Only) i.e. Rs.60,000/- (for dust violations) and Rs. 30,000/- (for illegal use of borewell) dated 21.11.2022 (copy enclosed) was issued to you.

And whereas, you, the addressee, have submitted reply which was found not satisfactory.

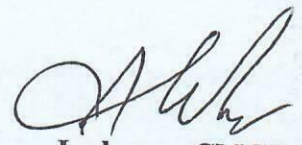
And whereas, case of your unit was placed before the Competent Authority in Delhi Pollution Control Committee and it has been decided to issue a reminder Show Cause Notice.

Now therefore as per "Polluter Pays Principle" and DPCC EDC policy dated 30.03.2022, following direction are hereby proposed to be issued:

1. That EDC of Rs. 90,000/- (Rupees Ninety Thousand Only) shall be imposed following 'Polluter Pays Principle' and DPCC EDC policy dated 30.03.2022.

Hence by way of this notice, you are hereby given one more opportunity to submit your reply as to why the aforesaid proposed direction of EDC of Rs. 90,000/- (Rupees Ninety Thousand Only) should not be confirmed. Your reply should reach to this office within 15 days from date of issuance of this Show Cause Notice, failing which it shall be assumed that you have nothing to say in this regard and the competent authority of DPCC shall be free to take action as proposed above. This may also be treated as last opportunity of being heard.

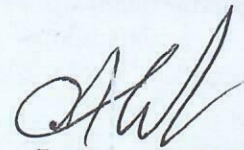
