Subject: Confirmation order for imposition of Environmental Damages Compensation-reg-

And whereas, you M/s Owner/Occupier, Kh.No. 962, Rithala, Delhi-110085 (herein after referred as addressee unit) is engaged in the activity of Dyeing and Washing of jeans.

And whereas, a joint inspection was conducted on 24.05.2024 by a team of officials of MCD, Delhi Police, TPDDL, DJB & DPCC and the deficiencies found during inspection are as follows:

1. Unit found engaged in the activity of Dyeing and Washing of jeans.
2. No effluent treatment plant was provided to treat the trade effluent generated during dyeing and washing of jeans.
3. No responsible person was available during inspection.
4. Unit was sealed on the spot by MCD officials and Electricity and water connection disconnected.
5. Unit is running without having consent from DPCC.

And whereas, the unit doesn't have valid Consent to Establish / Operate from DPCC, operating in violations of the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981, as amended to date.

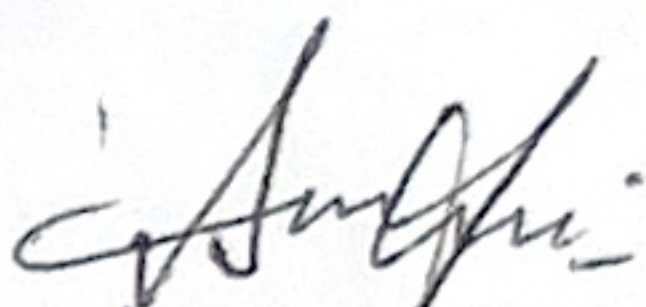
And whereas, Show Cause Notice for imposition of Environmental Damages Compensation (EDC) of Rs. 12,00,000/- (Rupees Twelve Lakhs Only) was issued to you vide letter no. F.No. DPCC/-L023/25/2025-CMC3/4350-52 dated 17.06.2025 and you have neither submitted your reply nor deposited any EDC in this office till date.

And whereas, as decided by the Competent Authority in Delhi Pollution Control Committee, the Environmental Damages Compensation of Rs. 12,00,000/- (Rupees Twelve Lakhs Only) has been levied upon you (the addressee unit).

Now therefore, the Competent Authority in Delhi Pollution Control Committee in exercise of powers conferred upon it u/s 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and 31(A) of the Air Act, 1981 as amended to date, has decided and keeping in view the 'Polluter Pays' Principle to issue the following directions:-

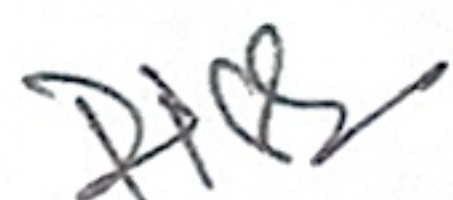
1. That you shall deposit the Environmental Damages Compensation of Rs. 12,00,000 (Rupees Twelve Lakhs Only) in the form of DD in favour of "Delhi Pollution Control Committee" within 15 days of issuance of these directions.

This is being issued as per the approval of Competent Authority, DPCC.
