Subject: Reminder Show Cause Notice (SCN) in the compliance of the orders of Hon'ble National Green Tribunal (NGT) in OA No. 601/2018 and provision of Air & Water Acts, issued on 08.06.2022 - reg.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (I) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. GSR 106 (E) dated 20.02.1987.

And whereas, it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall establish or operate any industrial plant in an air pollution control area.

And whereas, in Hon'ble Supreme court of India has ordered closure of impermissible industrial units in residential/non-conforming areas of NCT of Delhi vide order dated 07.05.2004 in Writ Petition (Civil) No. 4677/1985 apart from monitoring the matter on regular basis.

And whereas, in Hon'ble National Green Tribunal vide orders dated 05.08.2019 & 19.11.2019 in OA No. 601/2018 in the matter of "Mayank Manohar & Paras Singh, Reporter, the Times of India Vs. Govt. of Delhi & Ors." has also directed closure of impermissible industrial units in residential/ non-conforming areas of NCT of Delhi and levying Environmental Compensation (EC) for the damage caused by illegal operation keeping in view the 'Polluters Pay Principle'.

And whereas, you **Sh. Rajesh, Plot No. 5, Behind Shiv Mandir, Faridpuri, West Patel Nagar, Delhi-110008** (hereinafter referred as addressee unit) was engaged in the activity of Light Engineering work.

And whereas, an inspection was conducted by DPCC officials on **11.05.2022**.

And whereas, the addressee unit is operating without obtaining any Consent from DPCC which is a clear violation of the provisions of the Environmental Laws leading to unchecked pollution control mechanism and thereby damaging the environment.

And whereas, you, the addressee unit, were found engaged in the activity of Light Engineering work in non-conformity to MPD-2021 and found violating the environmental norms.

And whereas, in view of Hon'ble NGT direction/orders and violation, Competent Authority of DPCC by invoking the 'polluter pays' principle has decided to modify and levy Environmental Compensation (EC) of **Rs. 40,000/- (Rupees Forty Thousand Only)** on you (the addressee unit) for causing damage to the environment, which is being levied in view of office order **F.N. DPCC/RDPC/EC/2022/3522-3530** dated **30.03.2022** as per White category industry operating outside notified industrial/ Redevelopment Area.

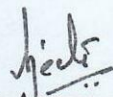
And, Whereas SCN was issued for imposing the Environmental Compensation (EC) of **Rs. 40,000/- (Rupees Forty Thousand Only)** to you, the addressee unit, dated **08.06.2022** (copy enclosed).

And whereas, you, the addressee unit, have neither submitted any reply nor deposited the EC till date.

And whereas, case of your unit was placed before the competent Authority in Delhi Pollution Control Committee and it has been decided to issue a reminder Show Cause Notice to give one more opportunity to submit your reply.

Now, by way of this reminder notice, you, the addressee, are hereby once again called upon to **Show Cause** as to why the above proposed directions should not be confirmed. The reply, if any, should reach to this office (at **ISBT Building, 4th & 5th Floor, GT Karnal Road, Kashmere Gate, Delhi-110006** and/or at cmc6dpcc2025@gmail.com) within 15 days from the date of issue of this notice. In case of failure, it will be presumed that the addressee has nothing to say in this regard and the aforementioned proposed directions shall be confirmed. This may again also be treated as an opportunity of being heard.

This issues as per the approval of the Competent Authority, Delhi Pollution Control Committee.
