Subject: Revocation of Directions for Closure dated 15.04.2025 issued by DPCC.

Whereas, physical inspection of RMC and construction project site at M/s RAM KUMAR CONTRACTOR PVT. LTD., KH No. 905/1 to 7/1/1, Gagan Cinema Chowk, Nand Nagri, near Mandoli Jail, Delhi-110093 (addressee) was carried out by the Delhi Pollution Control Committee (DPCC) officials on 22.10.2024.

And whereas, based on deficiencies observed during physical inspection, Show Cause Notice followed by Direction for closure and imposition of Environmental Compensation (EC) Rs. 4,70,000/- (Rupees Four Lakh Seventy Thousand Only) issued to you on 15.04.2025.

And whereas, you have submitted your reply dated 11.06.2025 along with DD of an amount Rs. 4,70,000/- in favour of DPCC in view of EC imposed by DPCC and requested to withdraw the closure directions /restoration of power supply.

And whereas, an inspection of the site was carried out by DPCC officials on 03.07.2025 and during inspection it was observed that no construction activity was carried out, dust mitigation norms were found complied with, electricity found disconnected.

And whereas, your case was considered by Competent Authority, DPCC and decided to revoke the Direction of Closure dated 15.04.2025.

Now therefore, in view of above, Directions for Closure dated 15.04.2025 issued to you, the addressee is hereby revoked with immediate effects.

You, the addressee shall comply with the dust mitigation norms.
