Subject: Reminder for Directions for Confirmation of Environmental Damage Compensation.

Ref: F. No. DPCC-L013/9/2025-CMC-3/4736-39 Dated 21.07.2025

Whereas, Central Pollution Control Board has delegated all its powers and functions under the Water (Prevention & Control of Pollution) Act, 1974 and under the Air (Prevention & Control of Pollution) Act, 1981 in respect of Union Territory of Delhi to Delhi Pollution Control Committee.

And whereas, the whole Union Territory of Delhi has been declared as an Air Pollution Control area, under sub section (1) of section 19 of the Air (Prevention & Control of Pollution) Act, 1981 vide notification no. GSR 106 (E) dated 20.02.1987.

And whereas, it is mandatory provision under section 21/22 of the Air (Prevention & Control of Pollution) Act, 1981 that no person without the previous consent of the DPCC shall establish or operate any industrial plant in air pollution control area.

And whereas, it is a mandatory provision under u/s 25/26 of the Water (Prevention & Control of Pollution) Act, 1974, that no person without the previous consent of the DPCC shall establish or take any steps to establish any industry, operation or process or any treatment and disposal system an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land or operate any industrial plant in air pollution control area.

And whereas, you, **M/s Vardhman Silver, E-7, Mangolpur, Phase-2, Delhi-110083** (herein after referred as the addressee unit) found operating and engaged in the activity of silver smithy (with trade effluent discharge) including electroplating and buffing.

And whereas, it is evident that you (i.e the addressee unit) is causing pollution and also damage to the Environment which is liable for action as per "Polluter Pays" Principle. Directions for Confirmation of Environmental Damage Compensation was issued to you (i.e the addressee unit) on 21.07.2025 for Rs.13,00,000/- (Rs. Thirteen Lakhs Only) and Reminder Letter was issued on 14.08.2025 but you have submitted Rs.6,50,000/- (Rs. Six Lakh Fifty Thousand Only) Via. DD. NO. 005194 dt- 27.08.2025.

Hence by way of this notice, you are hereby again directed to deposit the remaining Environmental Compensation of Rs.6,50,000/-(Rs. Six Lakh Fifty Thousand Only) by way of D.D in favour of Delhi Pollution Control Committee within 15 days of issuance of these directions, failing which penal action shall be initiated against you as per law.
