Sub: Show Cause Notice for Imposition of Environmental Damage Compensation (EDC)-reg.

Whereas, Hon'ble National Green Tribunal vide orders dated 05.08.2019 & 19.11.2019 in OA No. 601/2018 in the matter of "Mayank Manohar & Paras Singh, Reporter, the Times of India Vs. Govt. of Delhi & Ors." has also directed closure of impermissible industrial units in residential/ non-confirming areas of NCT of Delhi and levying Environmental Compensation (EC) for the damage caused by illegal operation keeping in view the 'Polluters Pay Principle'.

And whereas, in compliance of Hon'ble NGT order dated 22.07.2024 in the matter of "Ramesh Chand v/s Municipal Corporation of Delhi & Ors." in OA No. 146/2024, a joint inspection of your unit Mr. Pankaj S/o Srinivas Block B, B-11, New Ashok Nagar (hereinafter referred as addressee) was carried out by a team comprising of officials of DPCC, MCD and Delhi Police on 09.12.2024 & 10.12.2024

And whereas, during inspection, it was observed that you were operating in the residential/non-confirming area without obtaining license/consent from any government/ regulating body and engaged in activity of "Godown/ storage of plastic, paper, metal and cardboard scrap".

And whereas, activity carried out by the addressee is Godown/storage of plastics and as per the DPCC EC policy dated 30.03.2022 you are liable to pay environmental compensation of amount Rs. 1,00,000 /- (Rupees One Lakh only

in the form of DD in favour of DPCC.

Now therefore, you are hereby asked to show cause as why the Environmental Damages Compensation of Rs. 1,00,000/- (Rupees One Lakh only) should not be levied upon the addressee unit.

Your reply, (if any) should reach this office within 15 days from the date of issue of this notice. In case of failure, it will be presumed that you have nothing to say in this regard and the aforementioned proposed EC of Rs. 1,00,000/- (Rupees One Lakh only) shall be confirmed without any further reference in this regard.

This is being issued with the approval of the Competent Authority, DPCC.
