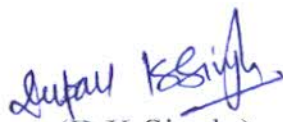

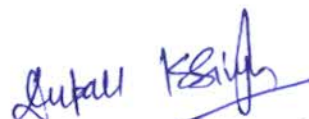

Minutes of the 10th Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by Member Secretary, DPCC for Consent Cases under Orange Category (2b Category), held on 19.05.2015. **Attendance Sheet is enclosed as Annexure "A".**

10th Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by the Member Secretary, DPCC for Consent Cases under Orange Category (2b Category), was held on 19.05.2015.

Pending Orange Category cases of April 2015 and Pending Consent to Operate /Renewal cases of Orange Category of the period 01.07.2014 to 20.02.2015 were taken up by the Committee in this meeting.

Minutes of the said meeting are as follows :

The Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions in case of 2(b) category cases in accordance with the office order dated 06.03.2012 & 22.09.2014.

Agenda Item No.1: Pending Consent to Establish cases of the period **01.04.2015 to 30.04.2015 (29 Cases)**.

(i) 14 Cases were categorised as of 2(b) category and decisions were taken online (Refer Agenda No 1- Annexure I).

(ii) 15 Cases were categorised as of 2(c) category and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer Agenda No 1- Annexure II).

The above mentioned Agenda excludes 22 cases of Consent to Establish of Mahipalpur area of the period 01.04.2015 to 28.04.2015 which were already taken up by the Committee headed by Chairman, DPCC in its meeting on 29.04.2015.

Agenda Item No.2: Pending Consent to Operate /Renewal cases of the period **01.04.2015 to 30.04.2015. (57 Cases)**

(i) 26 Cases were categorised as of 2(b) category and decisions were taken online (Refer Agenda No 2- Annexure I).

(ii) 21 Cases were categorised as of 2(c) category and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer Agenda No 2- Annexure II).

(iii) 10 Cases were categorized as of 2(d) category and further decision is to be taken by the Committee for 2(d) category cases headed by Chairman, DPCC (Refer Agenda No 2- Annexure III).

Agenda Item No. 3: Pending Consent to Operate / Renewal cases of the period **01.07.2014 to 20.02.2015. (109 Cases)**

(i) 93 Cases were categorised as of 2(b) category and decisions were taken online (Refer Agenda No 3- Annexure I).

(ii) 06 Cases were categorised as of 2(c) category and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer Agenda No 3- Annexure II).

(iii) 03 Cases were categorized as of 2(d) category and further decision is to be taken by the Committee for 2(d) category cases headed by Chairman, DPCC (Refer Agenda No 3- Annexure III).

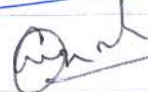
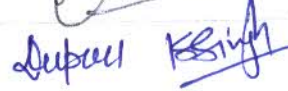
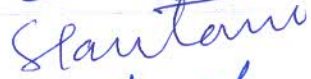
