

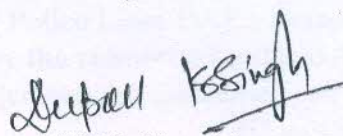

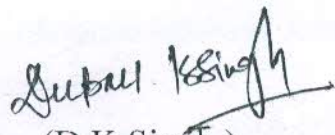

Minutes of the 2nd Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by the Member Secretary, DPCC for Consent Cases under Orange Category(2b Category), held on **21.11.2014.**

Attendance Sheet is enclosed as Annexure "A".

2nd Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by the Member Secretary, DPCC for Consent Cases under Orange Category(2b Category), was held on **21.11.2014.** Consent to Establish cases of **October , 2014** & Consent to Operate /Renewal cases of the period **16th Sept to 31st October , 2014** were taken up by the Committee in this meeting.

Minutes of the said meeting are as follows:-

The Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions in 2(b) category in accordance with the office order dated 22.09.2014.

Agenda Item No.1 : Consent to Establish cases of the period 01.10.2014 to 31.10.2014 (31 Cases)

- (i) **10 cases** were categorised as of 2(b) category and decisions were taken online (Refer **Agenda No 1- Annexure I**).
- (ii) **18 Cases** were categorised as of 2(c) category and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer **Agenda No 1- Annexure II**).
- (iii) **02 Cases** were categorized as of 2(d) category and further decision is to be taken by the Committee for 2(d) category cases headed by Chairman, DPCC(Refer **Agenda No 1- Annexure III**).

One EIA case of Construction of Residential Flats for Delhi Armed Police Line(DAP), Sector 9, Dwarka, Delhi 75 [ID No 9259, CTE, Dated 15.10.2014] was **not finalized by the concerned cell** and therefore could not be taken up by the Committee in the said meeting. It was decided that concerned cell to take necessary action and put up the case administratively :

Agenda Item No.2 :Consent to Operate/Renewal cases of the period 16.09.2014 to 15.09.2014 (145 Cases)

- (i) **65 cases** were categorised as of 2(b) category and decisions were taken online (Refer **Agenda No 2- Annexure I**).
- (ii) **68 Cases** were categorised as of 2(c) category and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer **Agenda No 2- Annexure II**).
- (iii) **10 Cases** were categorized as of 2(d) category and further decision is to be taken by the Committee for 2(d) category cases headed by Chairman, DPCC(Refer **Agenda No 2- Annexure III**).

Following 2 cases were not finalized by the concerned cell and therefore could not be taken up by the Committee in the said meeting. It was decided that concerned cell to take necessary action and put up these cases administratively :

- (ii)M/s Elmas (A unit of Leisure Zone Café Pvt. Ltd.), 73, Mehar Chand Market, Lodhi Colony, Delhi -03. [ID No 9230, CTO, Dated 10.10.2014].
