

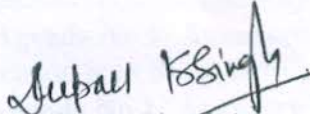

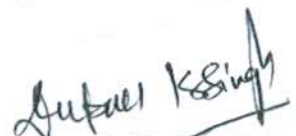

1st Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by the Member Secretary, DPCC for Consent Cases under Orange Category(2b Category),was held on 20.11.2014.

Consent to Establish & Consent to Operate /Renewal cases of September , 2014 were to be taken up by the Committee in this meeting however the Committee could take up the cases of Consent to Establish of Sept, 2014 & Consent to Operate /Renewal cases of upto 15th September , 2014 . It was decided that rest of the cases of Consent to Operate /Renewal of Sept, 2014 shall be taken in the next meeting of the Committee.

Minutes of the said meeting are as follows:-

The Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions /recommendations in accordance with the office order dated 06.03.2012 & 22.09.2014

Agenda Item No.1 : Consent to Establish cases of the period **01.09.2014 to 30.09.2014 (45 Cases)**

- (i) 17 cases were categorised as of 2(b) category and decisions were taken online (Refer **Agenda No 1- Annexure I**).
- (ii) 23 Cases were categorised as of 2(c) category and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer **Agenda No 1- Annexure II**).
- (iii) 05 Cases were categorized as of 2(d) category and further decision is to be taken by the Committee for 2(d) category cases headed by Chairman, DPCC(Refer **Agenda No 1- Annexure III**).

Agenda Item No. 2 : Consent to Operate/Renewal cases of the period **01.09.2014 to 15.09.2014 (59 Cases)**

The matter regarding generation of Hazardous Waste in form of cotton cloth containing Printing Ink from the Printing units was also discussed and the Committee recommended that such kind of hazardous waste may be disposed off by incineration in the Incinerators. Waste Management Cell III, dealing with the general issues related to Hazardous Waste to consider this recommendation for further necessary action in this regard.
