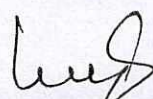
Sir,

The recommendation of the SEAC to delist the project was accordingly approved by the Authority in its 46th meeting held 10.04.2017

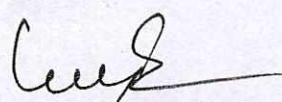
