

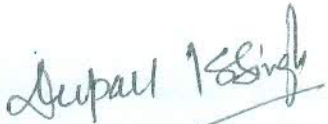

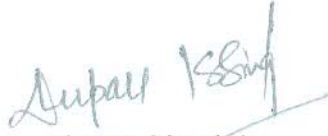

47th Meeting of the Screening Committee for Consent Cases under Orange Category (Applications of Consent to Establish / Operate /Renewal received under the Air & Water Acts and Authorization under the Hazardous Wastes Rules) was held on **25.02.2014** .

Minutes of the said meeting are as follows:-

The Screening Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions / recommendations in accordance with the office order dated 06.03.2012.

Agenda Item No.1 : Consent to Establish cases of the period 01.01.2014 to 31.01.2014(31 Cases)

- (i) In 13 number of cases were recommended as 2(b) category and decisions were updated online for implementation at the level of SEEs(Refer **Agenda No 1- Annexure I**).
- (ii) In 16 number of cases were recommended as 2(c) category and recommendations were updated online to be implemented with the approval of the Member Secretary, DPCC(Refer **Agenda No 1- Annexure II**).
- (iii) 02 Cases were recommended as 2(d) category which is to be put up administratively prior to placing before the committee headed by Chairman, DPCC(Refer **Agenda No 1- Annexure III**).

Agenda Item No.2 : Consent to Operate and Consent to Operate (Renewal) cases of the period 01.01.2014 to 31.01.2014 (205 Cases).

- (i) In 46 number of cases were recommended as 2(b) category and decisions were updated online for implementation at the level of SEEs(Refer **Agenda No 2- Annexure I**).
- (ii) In 52 number of cases were recommended as 2(c) category and recommendations were updated online to be implemented with the approval of the Member Secretary, DPCC(Refer **Agenda No 2- Annexure II**).
- (iii) 96 Cases were recommended as 2(d) category which is to be put up administratively prior to placing before the committee headed by Chairman, DPCC(Refer **Agenda No 2- Annexure III**).

Following 6 cases though fall in the chronology in the above mentioned period however **have not been entered by the IT Cell** of DPCC due to some issues involved and therefore could not be taken up / included in the above mentioned Agenda generated on line :

Agenda Item No. 3: 05 Cases of Consent to Operate / Renewal under orange category of the period **01.04.2012 to 31.12.2013** which were earlier not entered in want of categorization have now been entered by IT Cell and finalized by the Concerned Cell were also taken since these cases could not be taken in the earlier meetings of Screening Committee.
