

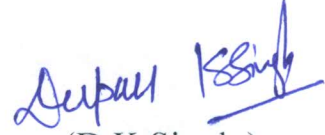

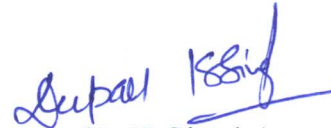

Minutes of the 49th Meeting of Screening Committee for Consent Cases Under Orange Category Held on 21.04.2014

49th Meeting of the Screening Committee for Consent Cases under Orange Category (Applications of Consent to Establish / Operate /Renewal received under the Air & Water Acts and Authorization under the Hazardous Wastes Rules) was held on **21.04.2014** .

Minutes of the said meeting are as follows:-

The Screening Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions / recommendations in accordance with the office order dated 06.03.2012.

Agenda Item No.1 : Consent to Establish cases of the period 01.03.2014 to 31.03.2014 (58 Cases)

- (i) In **21** number of cases were recommended as 2(b) category and decisions were updated online for implementation at the level of SEEs(Refer **Agenda No 1- Annexure I**).
- (ii) In **33** number of cases were recommended as 2(c) category and recommendations were updated online to be implemented with the approval of the Member Secretary, DPCC(Refer **Agenda No 1- Annexure II**).
- (iii) **03** Cases were recommended as 2(d) category which is to be put up administratively prior to placing before the committee headed by Chairman, DPCC(Refer **Agenda No 1- Annexure III**).

Case of M/s Indian Hotels Company Limited, Sector 21, Metro Station Complex, Dwarka, Delhi [ID No 7155, CTE, Dated 11.03.2014] though falls in the chronology in the above mentioned period however **has not been** finalized by the concerned Cell and therefore could not be taken up by the committee in the meeting. It was decided to put up this case administratively.

Agenda Item No.2 : Consent to Operate and Consent to Operate (Renewal) cases of the period 01.03.2014 to 31.03.2014 (122 Cases).

- (i) In **49** number of cases were recommended as 2(b) category and decisions were updated online for implementation at the level of SEEs(Refer **Agenda No 2- Annexure I**).
- (ii) In **52** number of cases were recommended as 2(c) category and recommendations were updated online to be implemented with the approval of the Member Secretary, DPCC(Refer **Agenda No 2- Annexure II**).
- (iii) **09** Cases were recommended as 2(d) category which is to be decided by the committee headed by Chairman, DPCC(Refer **Agenda No 2- Annexure III**).

Following 5 cases though fall in the chronology in the above mentioned period however **have not been entered by the IT Cell** of DPCC due to some issues involved and therefore could not be taken up / included in the above mentioned Agenda generated on line :

It was decided that concerned cell to take necessary action w.r.t entry of these cases by the IT Cell and after the entry put up the cases administratively.

Cases of M/s Raj Overseas, C 60/1, Wazirpur Industrial Area, Delhi 52 [ID No 7353, CTO, Dated 28.03.2014] and **M/s Rajeev Footcare Pvt. Ltd., 1st Floor, C-8, C- 9 & C -10, DSIDC Industrial Complex, Nangloi, Rohtak Road, Delhi 41** [ID No 7369, CTO, Dated 31.03.2014] though fall in the chronology in the above mentioned period however **have not been** finalized by the concerned Cell and therefore could not be taken up by the committee in the meeting. It was decided to put up these cases administratively.
