

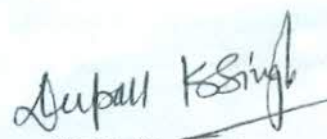

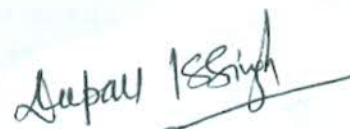

50th Meeting of the Screening Committee for Consent Cases under Orange Category (Applications of Consent to Establish / Operate /Renewal received under the Air & Water Acts and Authorization under the Hazardous Wastes Rules) was held on **13.05.2014**.

Consent to Establish & Consent to Operate /Renewal cases of **April, 2014** were to be taken up by the Screening Committee in this meeting however the **Committee could take up cases of Consent to Establish only, due to paucity of time and it was decided to take up the cases of Consent to Operate /Renewal of April, 2014 in the next meeting of the Screening Committee.**

Minutes of the said meeting are as follows:-

The Screening Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions / recommendations in accordance with the office order dated 06.03.2012.

Agenda Item No.1 : Consent to Establish cases of the period **01.04.2014 to 30.04.2014 (73 Cases)**

- (i) In **10** number of cases were recommended as 2(b) category and decisions were updated online for implementation at the level of SEEs(Refer **Agenda No 1- Annexure I**).
- (ii) In **59** number of cases were recommended as 2(c) category and recommendations were updated online to be implemented with the approval of the Member Secretary, DPCC(Refer **Agenda No 1- Annexure II**).

Consent to Establish cases of M/s KRF Ltd., C - 155, Phase II , Mayapuri Industrial Area, Delhi - 64 [ID No 7623, CTE, Dated 25.04.2014] and M/s Mcdonalds Family Restaurant, Show Room No. 17 to 24, Grindlays Cinema, Friends Colony Industrial Area, Delhi[ID No 7424, CTE, Dated 04.04.2014] though fall in the chronology in the above mentioned period however were **not** finalized by the concerned Cell prior to the meeting and therefore could not be taken up by the committee in the meeting. It was decided to put up these cases administratively.

Following 3 cases of the Consent to Establish of above mentioned period and pertaining to EIA Cell of DPCC have already been taken up by the Committee for 2(d) category cases headed by Chairman, DPCC in its meeting on **08.05.2014** and therefore these cases were not taken up in the meeting by Screening Committee :

- (i) M/s Parsvnath Landmark Developers Pvt. Ltd. (La Tropicana), Magazine Road, Khyber Pass, Civil Lines, Delhi [ID No 7451 CTE(Renewal), Dated 09.04.2014].
- (ii) Construction and Demolition Plant (National Building Construction Corporation Ltd.) E Block, near Badrinarayan Mandir, adjoining to E Block of East Kidwai Nagar, New Delhi -23. [ID No 7628 CTE, Dated 25.04.2014].
- (iii) M/s Best International Projects Pvt. LTD., Plot No. P -2, District Centre, Wazirpur, Netaji Subhas Place, Pitampura, New Delhi -34. [ID No 7647 CTE, Dated 28.04.2014].
