

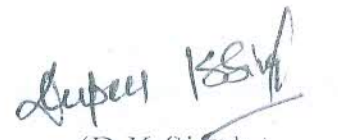

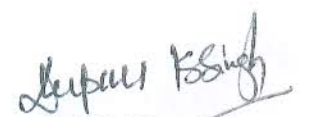

53rd Meeting of the Screening Committee for Consent Cases under Orange Category (Applications of Consent to Establish received under the Air & Water Acts and Authorization under the Hazardous Wastes Rules) was held on **21.05.2014**.

The Screening Committee was to take up the pending cases of Consent to Establish / Operate / Renewal (ATR Cases) of the **Period 01.01.2013 to 31.12.2013** in its **52nd meeting on 20.05.2014** however could take up Consent to Establish cases only due to Internet Problem (Network was working very slow). It was decided that rest of the Cases i.e. pending cases of Consent to Operate / Renewal (ATR Cases) of the Period 01.01.2013 to 31.12.2013 shall be taken in the next meeting (53rd) of the Committee on 21.05.2014.

Minutes of the said meeting are as follows:-

The Screening Committee took the **pending cases of Consent to Operate / Renewal of the Period 01.01.2013 to 31.12.2013** which were already taken by the Committee in its past meetings (ATR Cases) excluding the cases of Category 2(d) pertaining to the Committee headed by Chairman, DPCC.

The Screening Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions / recommendations in accordance with the office order dated 06.03.2012.

Agenda Item No.1: Pending Consent to Operate/Renewal cases of the period **01.01.2013 to 31.12.2013** (ATR)

- (i) In 69 number of cases were recommended as 2(b) category and decisions were updated online for implementation at the level of SEEs (Refer **Agenda No 1- Annexure I**).
- (ii) In 44 number of cases were recommended as 2(c) category and recommendations were updated online to be implemented with the approval of the Member Secretary, DPCC (Refer **Agenda No 1- Annexure II**).
