This has reference to your communication no. Nil received on 30.11.2010 and subsequent letters received on 20.12.2010 and 16.06.2011 made to State Level Environment Impact Assessment Authority (SEIAA) and forwarded to State Level Expert Appraisal Committee (SEAC) on the above mentioned subject.

1. The proposal was put up for consideration by the State Level Expert Appraisal Committee (SEAC) in its 26th, 28th, 29th, 30th and 32nd meeting held on 20.12.2010, 15.02.2011, 24.03.2011, 20.04.2011 and 30.06.2011 and the project proponent failed to attend the above mentioned meetings. Therefore, the Committee in its 30th meeting decided to **delist** the project.

In view of no response by the project proponent, State Level Environment Impact Assessment Authority (SEIAA) in its 15th meeting held on 12.12.2011 accorded approval to the decision of SEAC to close the file and **delist** the project from the list of pending projects for Environmental Clearance.
