



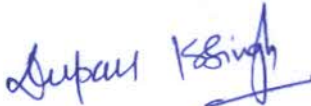

Subject: Minutes of the 58th meeting of the Screening Committee for Orange Category Consent Cases , held on 29.08.2014.

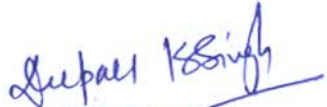

Minutes of the 58th Meeting of Screening Committee for Consent Cases Under Orange Category Held on 29.08.2014

Attendance Sheet is enclosed as Annexure "A"

58th Meeting of the Screening Committee for Consent Cases under Orange Category (Applications of Consent to Establish / Operate /Renewal received under the Air & Water Acts and Authorization under the Hazardous Wastes Rules) was held on **29.08.2014**.

Consent to Establish & Consent to Operate /Renewal cases of **July , 2014** were to be taken up by the Screening Committee in the meeting on **27.08.2014** however the **Committee could take up cases of Consent to Establish and 31 cases of Consent to Operate / Renewal upto 8th July,2014** , due to paucity of time and it was decided on **27.08.2014** that remaining cases of Consent to Operate /Renewal of July, 2014 shall be taken in the next meeting of the Screening Committee.

Minutes of the said meeting are as follows:-

The Screening Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions / recommendations in accordance with the office order dated **30.07.2014**.

Agenda Item No.1 : Remaining Cases of Consent to Operate /Renewal of the period 01.07.2014 to 31.07.2014 (119 Cases)

- (i) **115 cases** were decided as of 2(b) category and decisions were taken online (Refer **Agenda No 1- Annexure I**).
- (ii) **One case** was recommended as of 2(c) category and recommendations were updated online for further decision to be taken by the Committee for 2(c) category cases headed by Member Secretary, DPCC(Refer **Agenda No 1- Annexure II**).
- (iii) **One case** was recommended as of 2(d) category and recommendations were updated online. This case is to be placed before the Committee for 2(d) category cases headed by Chairman, DPCC(Refer **Agenda No 1- Annexure III**).

Consent to Operate (Renewal) cases of following units though fall in the chronology in the above mentioned period however were **not entered by the IT Cell of DPCC due to some issues involved and therefore** could not be taken up by the committee in the meeting:

- (i)**M/s J.S. Sahni Sons Energy System , B 26, Phase II, Mayapuri Industrial Area, Delhi 64**
[ID No 8505, CTR, Dated 18.07.2014].
- (ii) **M/s Aristo Stampings , 525, FIE Patparganj Industrial Area, Delhi 92**
[ID No 8536, CTR, Dated 21.07.2014]

It was decided that IT Cell/ concerned zone to take necessary action w.r.t entry of these cases and put up administratively for further necessary action in these cases.

Following **3 cases** of the Consent to Operate / Renewal (of the period 09.07.2014 to 31.07.2014) pertaining to earlier existing EIA Cell of DPCC have already been taken up by the Committee for 2(d) category cases headed by Chairman, DPCC in its meeting on **30.07.2014** and therefore these cases were not taken up in this meeting by Screening Committee :

- (iii) M/s Anant Raj Agencies Pvt. Ltd., Commercial Complex , 67, Najafgarh Road, Kirti Nagar, Delhi -15. [ID No 8562, CTR, Dated 24.07.2014].

Agenda Item No.2 : Consent to Establish case of M/s Pol Terminal Indian Oil Corporation Ltd., Tikri Kalan, N.H.10, Rohtak Road, Delhi 41[ID No 8322, CTE, Dated 03.07.2014]

This case is of July, 2014 however was **not** finalized by the concerned Cell and therefore could not be taken up by the committee in its earlier meeting on 27.08.2014 wherein it was decided that concerned zone to finalize this case and be taken up in the next meeting of the Committee.

Now the concerned zone has finalized the case and was taken up by the Screening Committee as Agenda Item No. 2 and this case was recommended as of 2(d) category and recommendations were updated online. This case is to be placed before the Committee for 2(d) category cases headed by Chairman, DPCC(Refer Agenda No 2- Annexure I).

It was brought to the Notice of the Screening Committee that Enquiry Counter of DPCC is not seeking copy of Membership of the CETP in case of Bawana Industrial Area whereas in case of other Industrial Areas where CETPs are operational, copy of Membership of the CETP Society is being asked while accepting the Consent applications. It was informed by the Incharge of Zone IX who is looking after all the matters related to CETPs that as per the amendments in the CETP Act, 2000, powers regarding recovering the share / dues from the Member Units / Industries of CETPs, towards operation and maintenance cost of CETPs have been delegated by the Industries Department to the concerned CETPs Societies and therefore the whole issue of seeking copy of Membership of the CETP Society while accepting the Consent application needs to be reviewed.

It was decided by the Screening Committee that Incharge Zone IX in consultation with Enquiry Counter to put up a separate note on this issue with proposal(s) for approval of the higher ups.

In case there is any case left out, inadvertently, of the aforementioned period, the same shall be put up administratively by the concerned zone for further necessary action.
