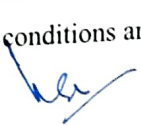

- e. In the review meeting of DPCC taken by chairman on 03.02.2025, it was decided that henceforth, in case of units on rent only registered rent agreements shall be accepted in case of RED category industries. In II(b) meeting dated 11.02.2025, the decision has been extended to all the units seeking consents under ORANGE and GREEN categories also. However, in this II(b) meeting dated 21.02.2025, the Committee has decided that consent applications which were applied before the date of 79th II(b) meeting i.e. 11.02.2025, may be processed as per the previous checklist and cases/applications received after 11.02.2025 may be granted only if Registered Rent Agreement is submitted by the applicant. Therefore, henceforth, all the units are required to submit either the ownership document in their name/ registered rent agreements with the owner only.

IT Cell needs to reflect this decision and give provision in the list of documents required while applying for consent accordingly.

In 79th II(b) meeting dated 11.02.2025, it was also discussed that the rent agreements and the validity of consents i.e 10 years in case of Orange category and 15 years in case of Green category, may not be concide. In this respect it was decided that validity of consent shall remain the same for corresponding categories with the condition to the units to upload renewed registered rent agreements regularly, that is after the end of tenure of previous rent agreement till the validity of consent. The consent conditions are to be modified accordingly.

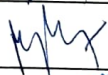
