Minutes of the 9th Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by Member Secretary, DPCC for Consent Cases under Orange Category (2b Category), held on 23.04.2015.

9th Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by the Member Secretary, DPCC for Consent Cases under Orange Category (2b Category), was held on 23.04.2015.

Pending Consent to Establish & Consent to Operate /Renewal cases of Orange Category of the period 01.01.2014 to 20.02.2015 were to be taken up by the Committee in this meeting however due to paucity of time only cases of Consent to Establish of this period and Consent to Operate / Renewal of the 01.01.2014 to 30.06.2014 could be taken up by the Committee and it was decided that Pending cases of Consent to Operate /Renewal of the period 01.07.2014 to 20.02.2015 shall be taken in the next meeting of the Committee for 2(b) Orange Category cases .

Minutes of the said meeting are as follows:-

The Committee segregated the cases under the category 2(b), 2(c) & 2(d) and gave decisions in case of 2(b) category cases in accordance with the office order dated 06.03.2012 & 22.09.2014.

Agenda Item No.1: Pending Consent to Establish cases of the period 01.01.2014 to 20.02.2015 (46 Cases)

(i) 35 Cases were categorised as of 2(b) category and decisions were taken online (Refer Agenda No 1- Annexure I).

In case of M/s Barista Coffee Company Limited, Ground Floor , Unit No G 2A, Janak Place District Centre, Janakpuri, Delhi 58 (ID No. 9810, CTE Dated 12.12.2014) decision is not found mentioned in the software generated list however in this case the Committee has already granted Consent to Establish while granting Consent to Operate , in its meeting on 26.02.2015 and accordingly concerned cell to take necessary action.

In case of M/s ARG Pack Plast Pvt. Ltd., Shed No. 7, DSIDC Industrial Area, Okhla Phase I, Delhi -20 (ID No. 10574, CTE Dated 17.04.2015) decision is not found mentioned in the software generated list however in this case the Committee found that online Consent application was earlier received from the unit and the same has already been considered by the Committee in its meeting on 17.12.2014 . On 17.12.2014 the Committee had taken following decision :

“ Ask the unit to submit hard copies of Consent application alongwith required documents. Also inspection be conducted”

As decided letter was issued to the unit on 19.02.2015 however hard copies of Consent application alongwith required documents not received. Inspection of the unit was also carried out on 10.04.2015 and deficiencies w.r.t compliance of the Hazardous Waste Rules were observed.

In view of the above the Committee decided to issue Show Cause Notice for Refusal of Consent & Authorization and put up the case for further necessary action .

(ii) 03 Cases were categorised as of 2(c) category including ID No. 7680 (M/s S.S. Silver star Accessories Pvt. Ltd. A-116, Mangolpuri Industrial Area, Phase II, Delhi) and further decision is to be taken by the Committee for 2(c) category cases headed by Chairman, DPCC (Refer Agenda No 1- Annexure II).
