This has reference to your communication no. F10(251)/AE(P)/ND-12/DDA/1401 received on 08.01.2008 to Ministry of Environment & Forests, GOI and forwarded to State Level Environment Impact Assessment Authority (SEIAA), NCT-Delhi on 14.08.2008 with respect to the subject mentioned above.

1. The proposal was put up for consideration by the State Level Expert Appraisal Committee (SEAC) in its 2nd meeting held on 29.12.2008 and the proponent was requested vide letter no. DPCC/PA/MS/SEAC/09/09 dated 21.01.2009 to submit the additional information/clarifications sought by the Committee.
2. A reminder in this regard was also sent vide letter no. DPCC/MS/SEAC-SEIAA/09/753 dated 06.1.2010, in response of which proponent had requested for two months time vide letter no. F.10(236)/AE(P)/ND-12/DDA/166 dated 22.02.2010 for the submission of requisite information sought by the Committee.
3. After expiry of the requested time period, a final reminder letter no. DPCC/MS/SEAC/10/1398 dated 02.11.2010 was sent again to the proponent for the submission of the requisite information.
4. In view of the no response from the project proponent, State Level Environment Impact Assessment Authority (SEIAA) in its 13th meeting held on 10.03.2011 has decided to close the file and delist the project from the list of pending projects. In case you wish to obtain Environmental Clearance in future, you may apply afresh to SEAC - NCT Delhi duly complying the clarification sought by the Committee during appraisal.
