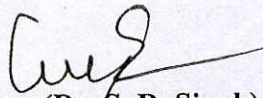
Sir,

This has reference to your application submitted on 03.03.2016 for seeking Environmental Clearance under Environmental Impact Assessment Notification dated 14.09.2006 amended as on date for the project mentioned in the subject above.

The case was taken up in various meetings of SEAC and in its 87th meeting held on 11.03.2017 recommended *to delist the case* in view of Gazette Notification issued vide S.O No. 3999 (E) dated 09.12.2016 and the observation of SEIAA in its 41st meeting dated 15.12.2016 deciding that with immediate effect only the building and construction projects falling under Category B of item No. 8 (b) will be dealt with SEIAA & SEAC, Delhi.

The recommendation of the SEAC to delist the project was accordingly approved by the Authority in its 46th meeting held on 10.04.2017.

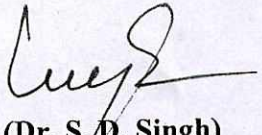
