Minutes of the 4th Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by Chairman, DPCC, for deciding applications of Consent under the Air & Water Acts and Authorization under the Hazardous Waste Rules, for the cases of Orange Category of Industries / Units [Category 2(c)], held on 29.04.2015, in respect of Pending Consent Applications of Mahipalpur area, in the conference room of Chairman, DPCC, at Delhi Secretariat, IP Estate, Delhi.

Vide Office Order dated 22.09.2014 a Committee headed by Chairman, DPCC, has been constituted to decide 2(c) category cases [Consent and Authorization of Orange Category units].

4th Meeting of the aforementioned Committee was held on 29.04.2015 in respect of Pending Consent Applications of Mahipalpur area irrespective of their category and decisions were taken online.

Following are the Minutes of the said meeting:-

Agenda Item No 1: Pending Consent to Establish cases under Orange Category of the period 01.01.2015 to 28.04.2015 (48 Cases).

Decisions were taken online in individual cases and software generated list of 48 cases is at Annexure I.

The Committee decided to issue Show Cause Notice for refusal of Consent to Establish in these 48 cases since required Documents (e.g. Licenses from concerned Municipal Corporation, Proof/Supporting Documents regarding source of water and related permission etc.) were not submitted by the units along with their Consent Applications.

Agenda Item No 2: Pending Consent to Operate cases under Orange Category of the period 01.01.2015 to 28.04.2015 (21 Cases).

Decisions were taken online in individual cases and software generated list of 21 cases is at Annexure II.

The Committee decided to issue Show Cause Notice for refusal of Consent to Operate in these 21 cases since required Documents (e.g. Licenses from concerned Municipal Corporation / Delhi Police, Test reports, Adequacy Report, Proof / Supporting Documents regarding source of water and related permission etc.) were not submitted by the units along with their Consent Applications.

Following General Decisions were taken by the Committee :

- (i) Since decisions are taken online in individual cases by the Committee and tabular list is generated through software including decisions taken in each case, there is no need of signature of the members of the Committee on such list. The concerned Cell may take necessary action w.r.t. decisions taken without waiting for the minutes of the meeting.
- (ii) Keeping in view the stand of Hon'ble National Green Tribunal on the issue of ground water extraction/drawl, it was decided not to issue Consent to any industry/unit, unless the industry / unit discontinues ground water extraction/drawl or submits a copy of permission to extract/draw ground water from the Competent Authority. If any Industry / Unit sources its water requirement from the Water Suppliers (through tankers etc), the Industry / Unit is required to submit the details of the water supplier(s) including source of water and required permission from the Competent Authority.

If there is any case left out of the aforementioned period, the same shall be put up administratively for further necessary action.

The meeting ended with a vote of thanks to the Chair.

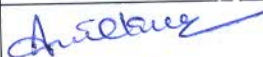
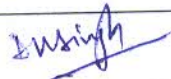
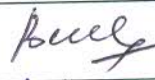
