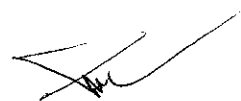

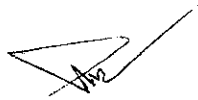
The meeting started at 11:00 am and was adjourned for 12:00 Noon for want of quorum. However the quorum could not be completed and following members were present in the scheduled meeting:
