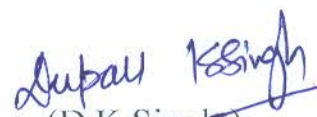

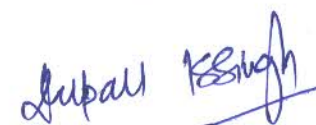

5th Meeting of the Committee constituted vide Office Order dated 22.09.2014 and headed by the Member Secretary, DPCC for Consent Cases under Orange Category(2b Category), was held on 26.02.2015.

Consent to Establish & Consent to Operate /Renewal cases of Orange Category of the period **21.12.2014 to 15.01.2015** were taken up by the Committee in this meeting.

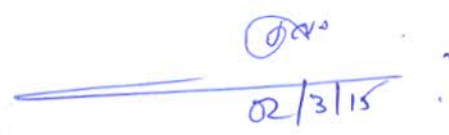
