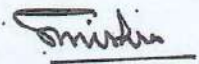
At the outset, Member Secretary, DPCC welcomed all the members and briefed about the action taken in view of the earlier meeting of HLC dated 02.07.2025.

2. Member Secretary, DPCC informed that since 17.05.2025 i.e. date of filing of affidavit by worthy Chief Secretary, GNCTD before Hon'ble Supreme Court, 06 candidates joined DPCC. 20 offers of appointments have been issued and the process is underway for the remaining offers.
3. The committee was also informed that rolling advertisement for filling up the deputation posts as per existing RRs has again been published in leading newspapers and that applications shall be processed in 3 phases with deadlines of 15th August, 31st August, 2025 & 15th September, 2025.
4. Member Secretary, DPCC informed that a proposal has been submitted through Environment Department, GNCTD for getting approval of Hon'ble Lt. Governor, Delhi for taking One Time Relaxation in respective RRs for filling up the following posts:-
 - (a) Junior Environmental Engineer (41 posts): The said posts is being filled up through using a list of "Non-Recommended Willing Candidates of Junior Engineer Exam., 2024 conducted by SSC, GoI (Considering Civil Engineering discipline)".

(b) Other remaining posts (44 posts) are being filled up through "by Deputation (including Short Term Contract) for Govt. Officials or Short Term Contract for retired persons from Govt. Organizations having age upto 62(till joining of regular employees)".

5. Member Secretary, DPCC also informed about the guidelines issued by DoPT vide OM. F.No.39020/01/2016 Estt. (B) Dated 21st December, 2020 to utilize the list displayed by the public recruitment agencies in their recruitment as per suitability of the post.
6. The Chairman directed that the Environment Department should expedite the proposal for seeking approval of the Hon'ble Lieutenant Governor, GNCTD for taking one time relaxation so that the vacancies can be filled up in time bound manner.
7. Next meeting of the said Committee will be held on 01.08.2025.

Meeting ended with vote of thanks to the Chair.
