ORDER

In pursuant to the compliance of National Green Tribunal Order in M.A. No.808 of 2013 in Original Application No. 94 of 2013 Vikrant Kumar Tongad Vs Delhi Metro Rail Corporation Limited vide dated 4th July 2014, four Committees had been constituted vide order no. 10(141)/(Env.)/2014/12145-12159 dated 17.07.2014. The Tribunal vide its order dated 18.02.2015 & 16.02.2015 in Original Application No. 94 of 2013 in the matter of Vikrant Kumar Tongad Vs Delhi Metro Rail Corporation Limited., has further directed to expedite the inspections and constitute more teams for conducting inspections.

In compliance to the above said order, following additional four Committees are hereby constituted regarding functioning status of rainwater harvesting structures installed in the nine districts(as per earlier boundaries).

The Report shall specifically indicate with what capacity of rain harvesting treatment device need to be, if it is already in place whether they are operational and achieving targets expected of such devices and if not, the measures the inspected units are required to take.
