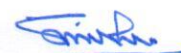
ORDER

In pursuant to the compliance of National Green Tribunal Order in M.A. No.808 of 2013 in Original Application No. 94 of 2013 Vikrant Kumar Tongad Vs Delhi Metro Rail Corporation Limited vide dated 4th July 2014 (copy of order enclosed), following four Committees are hereby constituted regarding functioning status of rainwater harvesting structures installed in the nine districts(as per earlier boundaries).
